COUNTY ROAD 23-136**

WHEREAS, the Board of County Commissioners of Sublette County, Wyoming finds that after a traffic investigation that the maximum speeds on Paradise County Road 23-136, should be adjusted to reflect the following:

1. Station 2+50 – Station 362+50 – 50 mph
2. Station 362+50 – Station 441+63 – 40 mph
3. Station 441+63 – Station 687+63 – 50 mph
4. Station 687+63 – Station 731+63 – 40 mph
5. Station 731+63 – Station 772+63 – 30 mph





**A RESOLUTION AMENDING THE SPEED LIMIT ON PINEDALE SOUTH COUNTY ROAD 23-123**

1. The speed limit on Pinedale South County Road 23-123 south from its intersection with Granite Lane County Road 23-205 shall be amended to 35 miles per hour.



